

## PRODUCT PROPERTIES / APPLICATION AREA:

LIPSTICK FROST & SUN protects and cares the lips intensively, especially in case of aggressive outside influences such as coldness, wind and dry air. LIPSTICK FROST & SUN is suitable for rough, chapped and dry lips. Moreover, LIPSTICK FROST & SUN offers protection against damages caused by natural UV radiation. Due to their thin horny layer, human lips are quite sensitive to outside influences. The lips, as well as forehead, nose and ears, belong to the so-called sun terraces and cannot protect themselves against UV radiation by tanning. The second protective mechanism is inapplicable as well, as no light callosities evolve on the lips. This means that the outer skin layer does not thicken under the incident sunlight. In the long term, the lips are threatened by damages caused by too much sunlight, called "farmer's lips" or "sailor's lips". In order to protect the lips, special protection products are necessary, since "wrong" products carry the risk of being "licked-away" quickly and, thus, of an oral intake.

## APPLICATION:

Apply LIPSTICK FROST & SUN several times a day – as needed – on your lips. LIPSTICK FROST & SUN can be easily applied and does not leave a colored film on the lips. The product is recommended for men and women.

Before intensive light exposition, apply LIPSTICK FROST & SUN evenly on the clean and dry lips. Apply amply, small amounts provide low protection only. In order to maintain the protective effect, apply LIPSTICK FROST & SUN several times a day. However, the re-use does not extend protection time but restores the old protective condition which was reduced in the meantime. In general, the renewal of the protective film every two hours is reasonable.

Please note: The application of light protection agents does not exonerate from the application duty of other prescribed precautionary measures. Intensive midday sun should be avoided. Even protection agents with a high SPF do not provide complete protection against UV radiation.

## PRODUCT DESCRIPTION:

Lip care in form of a stick based on waxes, oils and lipids as well as on cosmetic ingredients. The characteristic yellow-orange color of the lipstick originates from the contained sallow-thorn pulp oil.

## DERMATOLOGICAL COMPATIBILITY:

LIPSTICK FROST & SUN'S dermatological compatibility has been carefully tested and proven. A printed certificate is available.

## PRODUCT QUALITY:

The product is manufactured according to GMP (GOOD MANUFACTURING PRACTICE) requirements. The bacteria count is microbiologically tested on a regular basis and is under 100 bacteria per gram.

## FIRST AID:

If LIPSTICK FROST & SUN accidentally gets into your eyes, rinse immediately with plenty of lukewarm water. If a burning sensation still persists, consult an eye doctor as measure of precaution.  
If swallowed, do not induce vomiting. Rinse mouth with water and drink one glass of water. Consult a doctor or the Poison Information Centre if necessary.  
If medical advice is needed, have product container or label at hand.

## STORAGE INSTRUCTIONS:

LIPSTICK FROST & SUN will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on the stick. Store it in a cool and dry place (room temperature). Close after use.

## STATUTORY REGULATIONS:

LIPSTICK FROST & SUN is subject to the EC Cosmetics Directive but not to the German Chemicals Act or the Hazardous Substances Order. Moreover, skin protection products are received as part of the Personal Protective Equipment (PPE).

## ENVIRONMENT:

Lid and rotary base are made of SAN and after being completely emptied, they can be disposed of with other SAN waste.
